## **Guidelines for SEC**

- 1. The college will allot the SEC subjects on a first come first serve basis.
- 2. Students will not be allowed to change their SEC subjects at a later stage. Therefore, the students should follow extreme care while choosing their options.
- 3. Students are advised to go through the syllabi of the Skill Enhancement Courses (SEC) before choosing their options. The syllabi are available on the DU website: <a href="https://www.du.ac.in/">https://www.du.ac.in/</a>
- 4. Students cannot opt for the same paper in Semester V which they have studied in any of the previous semester (Semester I, II, III and IV). For example: if the student has studied the SEC Paper "Digital Marketing" in any of the previous semester (Semester I, II, III or IV), then he/she cannot opt the same paper in Semester V.
- 5. Semester V students are also informed that they may study any SEC other than those provided by College of Vocational Studies. For details regarding other SEC papers, kindly check the DU website <a href="https://www.du.ac.in/">https://www.du.ac.in/</a>. In such a case, students are required to send an email at <a href="mailto:subjectoptions@cvs.du.ac.in">subjectoptions@cvs.du.ac.in</a> mentioning their Name, Roll Number, Course, Contact Number, and SEC paper that they wish to study in Semester V. In case the student opts for a SEC paper not offered by College of Vocational Studies, they will have to attend classes in any other college belonging to the Cluster Colleges (South Campus) of the University of Delhi. The fulfillment of the choice of the student depends on the terms and conditions set by the host college.
